2018/19 Schools Self-Assessment for Determining Grades and 2018/19 Incidents, Trainings, Programs for Report Period 2

Mr. DeSocio

Mr. DeSocio presented the Annual Schools Self-Assessment for Determining Grades for the 2018/19 school year and the Incidents, Trainings, Programs for Report Period 2 for the 2018/19 school year which is required by the New Jersey Department of Education in accordance with the Anti-Bullying Bill of Rights Act. Highlights of his presentation included:

#### **School Self-Assessment for Determining Grades:**

Out of a possible 78 points, Reynolds scored 75 points, Bogert scored 74 points and Cavallini scored 74 points. The District Grade was 74.

#### **2019 District Performance Report**

Mrs. D'Ambola

Mrs. D'Ambola reported district progress on standardized testing for the 2018/19 school year. Data from NJSLA, Access 2.0 and DLM were analyzed and an update for science testing was provided. Additional focus was put on comparative data, including district/state results, subgroup data and district participation. The presentation also outlined how professional development is supporting the analysis of NJSLA data alongside our local, formative (Link It!) assessment data. Multiple reports were shared to highlight how the district is using data to target interventions for students needing additional support and those in need of enrichment opportunities.

- Mrs. Pittman commented that Link It information is so helpful for teachers in understanding students and to structure instruction.

The Upper Saddle River Board of Education agrees not to solicit bids or quotes or to enter into a contract that would jeopardize the award of a contract for Cooperative Purchasing of Electricity by the Commission. The Upper Saddle River Board of Education agrees to abide by the award of contract made by the Commission if the Commission determines that the bidder is qualified. The Upper Saddle River Board of Education will not withdraw from the cooperative without providing at least 30 days advance notice of their intent before the next preparation of bid specifications or contract extensions.

The Commission will prepare bid specifications, evaluate bids submitted and award a contract for the purchase of Electricity. The Commission will also monitor the performance of the vendor during the course of the contract.

In lieu of the participation fee, the Commission will receive a .00125 per kilowatt hour commission from the successful bidder for the services rendered by the Commission, including preparation of specifications, transmittal of bid specifications, bid evaluation and contract documents.

The Educational Services Commission of New Jersey is authorized to act as the District's agent in the award of an Electricity Procurement contract and execute purchase contracts at time of bid.

The Commission will prepare bid specifications, evaluate bids submitted and award a contract for the purchase of Natural Gas. The Commission will also monitor the performance of the vendor during the course of the contract.

In lieu of the participation fee, the Commission will receive a .00650 per therm commission from the successful bidder for the services rendered by the Commission, including preparation of specifications, transmittal of bid specifications, bid evaluation and contract documents.

The Upper Saddle River Board of Education hereby authorizes the Education Services Commission of New Jersey to act as agent for the purpose of executing a purchase agreement for Natural Gas.
