Bogert PE/Health Teachers, Ms. Blumenfeld and Mr. Petrow, presented on the Bogert outdoor team-building course. They also showed a video of students using the course and presented feedback from the students about what they enjoy about the course and how it helps them reach goals.

Mr. DeSocio presented the Annual Schools Self-Assessment for Determining Grades for the 2020/21 school year and the Incidents, Trainings, Programs for Report Period 2 for the 2020/21 school year. Highlights of his presentation included:
