Mrs. Wenberg thanked the Board for the opportunity to announce the USREF Fall Grant recipients. She also thanked Mr. Padilla for his help in creating the grant application form and compiling the completed proposals for the Grant Committee's review. Highlights of her presentation included:

To promote innovation, creativity and excellence in the Upper Saddle River Schools by supporting and enhancing the curriculum of Pre-K through 8th grades while benefitting the broadest number of children.

Two other grants were submitted this fall. The Committee is continuing to work with the grant writers on them and, hopefully, they will be approved at a later date.

Planning for the Media Center renovations to 21st Century Learning Commons in Bogert and Cavallini is in progress. The USREF kicked off a major fundraising effort called USREF Partners in Education with a fundraising website: www.bidpal.net/usrefpartner. A mailing was sent to all district families and response has been good so far. The website will be kept current as planning progresses.

Mrs. Wenberg also reminded everyone about the annual fundraising gala this spring, the USREF Town Night Gala, which will be held March 28, 2020 at Edgewood Country Club in River Vale, NJ.

2. **Special Education Programs**

Mrs. Apicella

Mrs. Apicella and the Special Education Teachers discussed the types of programs in the self-contained settings. The K-2 LLD and Grades 3-5 LLD align grade level standards while scaffolding skills for students with various learning needs. The ABA Pre-K and K-2 classes consist of students on the autism spectrum as well as developmental abilities. These classes work on filling gaps, teaching self-help skills and work on getting students to be prepared to learn grade level standards. More repetitive instruction and 1:1 teaching is the focus in these classrooms.

DISCUSSION:

- On behalf of the Board, Mrs. Johnston thanked the USREF for their generosity and continued support.
- Mrs. Johnston thanked Mrs. Apicella for sharing about the creative and innovative programs and how they are keeping these children engaged and moving along.
- Dr. Siegel said that these programs are still in their infancy stages and are a testament to the teachers, paraprofessionals and administrators. These programs are a major aspect of what we do and they should be proud. Our number of out-of-district vs. in-district students has changed dramatically. He is proud to say that less than 10 students are out-of-district this year
