Mrs. Wenberg thanked the Board, the Grant Committee volunteers who reviewed evaluated and approved the grants, Mrs. D'Ambola for sharing her curriculum expertise and Mr. Padilla who put together the grant applications and compiled the data. Highlights of her presentation included:

Grant Objectives:

To promote innovation, creativity and excellence in the Upper Saddle River Schools by supporting and enhancing the curriculum of Jr. K through 8th grades while benefitting the broadest number of children.

Twelve recurring grants were approved in Spring 2018 (\$15,538). Total 2018/19 Grants awarded in the amount of \$38,504.

2. Middle School Cycle Course Redesign

Mr. McCusker/Mrs. D'Ambola

Mrs. D'Ambola and Mr. McCusker provided an update on the review and redesign of the cycle courses at Cavallini. A committee of administrators, teachers and students used site visits and reflection sessions to guide a recommendation, which was the focus of this presentation. This new structure will increase the amount of student choice and gradually progress to a more individualized learning experience for students. Students from the committee provided the Board and their perspective on being part of this process and detailed the experiences these new courses will offer students. New courses will be offered to 6th grade students in 2019/20 and 7th and 8th grade students in 2020/21.

- Mrs. Johnston thanked the Administrative team and students and said it was nice to see more choices being built into the curriculum. She said it is better preparing students for when they get to Northern Highlands. She also thanked the students for their feedback.
